Built-in Assumptions:

Costs remain virtually the same in 2022 as 2021, except for the following:

- \$7,612 for a pond fountain
- \$7,500 per year for 3-4 years for "Jungle Reclamation"
- 3 snowfalls >2.6" in Nov. & Dec. '22
